Wyoming Statute (W.S.) Section (§) 1-1-123(a) states: "Any person who takes part in any sport or recreational opportunity assumes the inherent risks in that sport or recreational opportunity, whether those risks are known or unknown, and is legally responsible for any and all damage, injury or death to himself or other persons or property that results from the inherent risks in that sport or recreational opportunity." As a provider of this recreational opportunity, the below-signed acknowledges that Wyoming State Parks & Cultural Resources, Wyoming Mountain Bike Camps, Inc., and any related entity or individual "is (are) not required to eliminate, alter or control the inherent risks within the particular sport or recreational opportunity" (W.S. § 1-1-123(b)). I promise not to sue anyone associated with this event regarding any claim arising from my participation in this event.**

I certify that I am physically fit and have not been advised otherwise by qualified medical personnel to not participate in this event. I acknowledge that this El Alto Mountain Bike Camp Accident Waiver, Release of Liability, and Consent Form applies to all activities associated with the 2022 El Alto Mountain Bike Camp and that it will govern my actions and responsibilities during the 5 days (June 25, 26, 27, 28, and 29, 2022) of the El Alto Mountain Bike Camp event(s).
